Policy Update

Launch of Community Health Centers Vaccination Program

The President announced next week's launch of the <u>Federally Qualified Health Center Vaccine program</u> that will provide more vaccines for Community Health Centers that are reaching our underserved and most vulnerable communities. The program will be phased in, with the first centers able to start ordering vaccines as early as the week of February 15. The initial phase will include at least one Community Health Center in each state, expanding to 250 centers in the coming weeks.

Percent of Delivered First Vaccine Doses Administered by U.S. States and Territories

This map shows the <u>percentage of first doses of vaccines that have been administered</u> in each state from their supply, which can be used to understand how states are using their supply to initiate vaccination within their community. The map is created as part of the <u>National Strategy for the COVID-19 Response and Pandemic</u> <u>Preparedness</u>, where CDC is committed to making sure that safe, effective vaccines are distributed and administered as quickly as possible.

<u>CDC warns states against lifting restrictions amid threat of virus variants</u> (The Hill, 02/0/21) CDC Director Rochelle Walensky urged states against lifting coronavirus restrictions, citing the ongoing virus threat and more contagious variants on the rise despite lower case counts overall.

New variants raise worry about COVID-19 virus reinfections (AP, 02/08/21)

Evidence is mounting that having COVID-19 may not protect against getting infected again with some of the new variants. People also can get second infections with earlier versions of the coronavirus if they mounted a weak defense the first time, new research suggests.



FDA Gearing Up for Rapid Review of Potential COVID-19 Booster Shots (Reuters, 02/08/21)

The U.S. Food and Drug Administration is planning a rapid review process for quick turnaround of new COVID-19 booster shots if variants of the coronavirus emerge against which the vaccines do not provide protection. The agency plans to issue a proposal on the process for public comment in a few weeks, she said during a press briefing. That process will likely require safety information as well as, if possible, the convening of an outside committee of experts to review the booster shot.
