Provider Updates

FDA COVID-19 Update

The <u>FDA announced the following actions</u> (02/16/21) taken in its ongoing response effort to the COVID-19 pandemic:

- Warning letter issued to <u>Evolved Ayurvedic Discoveries</u>, <u>Inc./BioCBDPlus</u> for selling misleadingly represents the products can mitigate, prevent, treat, diagnose or cure COVID-19 in people.
- Testing updates: As of today, 331 tests and sample collection devices are authorized by the FDA under emergency use authorizations (EUAs).

- <u>Pfizer-BioNTech vaccine sharply reduces symptomatic Covid-19</u> (CNN, 02/16/21)
 Pfizer-BioNTech's <u>Covid-19 vaccine</u> appears to reduce symptomatic coronavirus infections by more than 90% in the real world.
- The coronavirus is here to stay here's what that means (Nature, 02/16/21)
 In January, Nature asked more than 100 immunologists, infectious-disease researchers and virologists working on the coronavirus whether it could be eradicated. Almost 90% of respondents think that the coronavirus will become endemic meaning that it will continue to circulate in pockets of the global population for years to come.
- Pandemic cut U.S. life expectancy by a year during the first half of 2020 (The Washington Post, 02/18/21)
 - Life expectancy in the United States fell by a full year during the first half of 2020, a staggering decline that reflects the toll of the covid-19 pandemic as well as a rise in deaths from drug overdoses, heart attacks and diseases that accompanied the outbreak. Americans can now expect to live as long as they did in 2006, according to the provisional data released by the National Center for Health Statistics.
