Policy Update

FDA Advisory Panel Recommends EUA for Pfizer COVID-19 Vaccine

The FDA's Vaccines and Related Biological Products Advisory Committee, whose recommendations the FDA usually follows, has voted in favor of emergency use authorization for the COVID-19 vaccine developed by Pfizer and BioNTech. The company intends to seek full approval for the vaccine by April of 2021.

CMS updates guidance on billing for COVID-19 treatment

The CMS has updated its <u>infographic</u> and frequently asked <u>questions</u> on payment guidelines for monoclonal antibody COVID-19 treatments. The FAQs offer general payment and billing details on hospital services, laboratory testing and inpatient prospective payment system payments, while the infographic provides information about expected Medicare payments to clinicians and how Medicare recipients can receive COVID-19 drugs without cost sharing.

People Who Have Tested Positive for Covid-19 Should Still Get Vaccine

CNN shared an article about Dr. William Moss, an infectious disease pediatrician at Johns Hopkins University, encouraged anyone who has already tested positive for Covid-19 to get vaccinated once a vaccine becomes available. Moss added there is some potential that someone who has already tested positive for Covid-19 can produce a stronger antibody response once vaccinated. However, this is not the case for all vaccines, he said. Read the article on the CNN website.

CDC Updates COVID-19 Racial and Ethnic Health Disparities Webpage
