# ALC2024 CONFERENCE TERMS AND CONDITIONS

Thank you for registering for ALC2024 (the "Conference"). The following Conference Terms and Conditions ("Terms and Conditions" or "Terms") apply to you and your participation in the Conference. These Terms also apply to you if another individual registered you at your request. Your Conference registration may include in-person programming (including general admission keynotes, general education sessions, reception and exhibition), digital access to programming (including exclusive content), and/ or any optional pre-conference symposia, special events or special in-person or digital programs you choose to add onto your Conference registration, to the extent offered. "Attendee" for purposes of these Terms will include all participants at the Conference, including exhibitors, sponsors, speakers, press, partners, and individual attendees. By participating in this Conference, you agree to these Terms so please read them carefully.

This Conference is organized by the National Hospice and Palliative Care Organization ("NHPCO"), which reserves the right, in its sole discretion, to limit or deny access to any entity or individual.

## Payment Terms

Submission of a registration online, by phone or email, constitutes an official registration and intent to attend the Conference. Invoices are payable upon receipt, and full payment must be received in order to gain entry to the Conference. Please note that payments must be charged to Visa, MasterCard, American Express or Discover. ACH and check payments are also accepted. Purchase orders and cash are not accepted.

You agree that, in the unlikely event that NHPCO cannot resolve a payment issue and you dispute the credit card charge, your electronic statement may be used as evidence that said charge is valid and just. If there are any issues with your credit card charge, please contact NHPCO's Solutions Center at <u>conferences@nhpco.org</u>.

Please remember that Conference fees do not include NHPCO membership fees. Any NHPCO membership fees paid as part of the Conference registration are non-refundable and non-transferrable.

### **Registration Confirmation**

### **Cancelation and Substitution Policy**

All cancelations and refund requests must be made in writing. A refund of the conference fees, minus a \$50 administrative fee, will be provided for cancelations received by June 8, 2024. Cancellations between June 9 and August 29, 2024, will receive a 50% refund less the \$50 administrative fee. No refunds will be granted for requests postmarked after August 29, 2024. Substitutions must be submitted on/before August 29, 2024. Please submit your request in writing. All registration changes (on-demand to in-person or in-person to on-demand) are subject to a \$50 change fee. Send cancelation or substitution requests via email to <u>conferences@nhpco.org</u>. Refunds or credits will be processed within 15 business days after the conference. ### **Conference Cancelation or Modification**

NHPCO reserves the right to cancel, alter, or reschedule the Conference for any reason, including because NHPCO determines in its sole discretion that the Conference cannot be held as planned. NHPCO also reserves the right to close registration when tickets are sold out. NHPCO reserves the right to substitute faculty or to cancel or reschedule sessions due to low enrollment or other unforeseen circumstances. For these reasons, registrants are advised against making non-refundable travel arrangements. Should you purchase non-refundable airline tickets or make non-refundable hotel reservations, you do so at your own risk.

Should NHPCO cancel, alter, or reschedule some or all the in-person portion of the Conference for any reason, while retaining the digital portion, Attendees are automatically registered for and will be provided with access to the ALC2024 digital environment. Once you are automatically registered for the digital environment, the remaining portion of your Conference fees (including any optional in-person events) will be refunded.

Should NHPCO cancel, alter, or reschedule some or all the digital portion of the Conference for any reason, Attendees registered for the digital portion only may adjust their registration to in-person and pay any registration fee differential; otherwise, digital/on-demand conference fees will be refunded. Should NHPCO cancel, alter, or reschedule some or all the in-person and digital portions of the Conference for any reason, Conference fees (including any optional in-person events) will be refunded.

By completing the registration process and acknowledging these Terms and Conditions, you are providing your consent for NHPCO to share your limited registration information (meaning name, company name, job titles, city, state and/or country) on the NHPCO attendee roster.

# Communications from NHPCO

By completing the registration process and acknowledging these Terms and Conditions, you are providing your consent to receive emails and other mailings from NHPCO related to the Conference in order to facilitate your participation. Specifically, you are providing your consent to allow NHPCO to use your Contact Information to facilitate access to Conference programming, NHPCO digital platforms, and related events and content.

# Attendance at Exhibitor Sessions and Sponsored Activities

By registering for an exhibitor or supporter session/activity or attending an exhibitor or supporter session/activity (whether virtual or in-person), you are providing your consent and you agree that Contact Information provided to NHPCO may be shared with respective exhibitors or supporters; additionally, you agree to receive communications

#### NHPCO Badge Scanning

Please be aware that exhibitor and supporter scanning of attendee badges is optional, and you may refuse to have your badge scanned at booths as well as at the entrance to exhibitor or supporter sessions and functions without penalty; you acknowledge that if you do not permit sharing of your Contact Information in this context, you may not be able to attend certain sessions or functions.

### **Digital Content Access**

By completing the registration process and acknowledging these Terms and Conditions, you acknowledge and agree that NHPCO will be offering certain digital content via one or more digital platforms. Depending on the platform(s) NHPCO deploys, access to the digital content may be through a website or through an app you need to download on your device(s). NHPCO will provide login credentials to you (usually by email) prior to the first session. Additionally, the virtual event platform will support features equivalent to scanning your badge at an in-person event. For the event to function effectively your participation may be visible on the platform(s) and other attendees may be able to contact you via the platform(s). If you choose to interact with another attendee, you agree to permit NHPCO to share your event networking profile with that attendee. You can opt out of this sharing by not interacting with other attendees and you can also control what information is available in your event networking profile, including any contact details.

#### **Guest Speakers**

Guest speakers are not employees of NHPCO and NHPCO neither pre-reviews nor comments on the content of our guest speakers' sessions. Guest speaker views and opinions are entirely their own and in no way reflect the views and opinions of NHPCO.

#### Health and Safety

Considering ongoing concerns regarding COVID and communicable health risks more generally, NHPCO will implement health and safety protocols appropriate to the public health circumstances existing at the time of the Conference. NHPCO will exercise reasonable efforts to utilize protocols that will comply with or exceed any local public health requirements and be consistent with then-prevailing public health standards as issued by relevant public health entities. Those protocols may include but are not limited to the following requirements: vaccination, proof of COVID status, self-monitoring, biometric screening, symptom checkers, contact tracing, use of personal protective equipment and social distancing, or other similar measures. Compliance with some or all of the protocols adopted by NHPCO may be mandatory for attendance and participation at the Conference. You specifically agree that you will not attend the Conference if, within five days preceding the Conference, you have:

- 2. Experienced any symptoms commonly associated with COVID or other communicable disease; or
- 3. Been in direct contact with or the immediate vicinity of (collectively, the "Encounter") any person who is either confirmed or suspected of being infected with COVID or other communicable disease within the last five days.

Further, you understand and agree that NHPCO may share any COVID or other communicable disease-related information about you that NHPCO receives as part of such health and safety protocols with public health authorities or other regulatory agencies, as required under applicable laws.

### Use of Multimedia

By attending the Conference, you acknowledge and agree that NHPCO, or others acting on its behalf or through supporter or exhibitor contracts, may take photographs and video (by any means) and/or make sound recordings during the Conference (including through the digital event platform and via social media) and that you may appear in such photographs and videos and be heard in such sound recordings, and that NHPCO may edit and use the footage it captures at the in-person and digital Conference for marketing and promotional activities (including through social media) now and in the future, and for any other lawful purpose in the ordinary course of its business.

## Code of Conduct

You agree not to copy or permit to be copied, in any form or format, without the express written permission of NHPCO, any of the contents of the Conference attendee roster.

You also agree not to use the roster contents for any commercial, marketing, promotional or political purposes.

No solicitation is permitted except by exhibitors within the confinement of their booths. NHPCO reserves the right to escort any individual from the Conference who is reported to be soliciting and who is not an NHPCO exhibitor.

Attendees are expected to behave responsibly and to treat each other and the community with respect, kindness and compassion. Failure to behave in such manner, as determined in NHPCO's sole discretion, may result in removal from the in-person and/or electronic Conference and deactivation and/or revocation of credentials, without refund.

The Conference is a private event, and weapons are strictly prohibited. Attendees are forbidden from carrying weapons of any kind, including concealed or displayed firearms or knives, onto the premises of the Conference. NHPCO reserves the right, in its sole discretion, without refund, to deactivate and/or revoke the credentials of Attendees who violates this policy. By registering for the conference, you agree to comply with this policy, regardless of any signage located on the premises of the Conference.

For security reasons, badge swapping or sharing of access credentials is not permitted. Anyone found wearing a badge that does not match that person's identification or using another person's access credentials for the in-person conference will be evicted from the Conference without a refund, and that person's registration will be canceled.

Additionally, anyone sharing their access information or login credentials in connection with any component of the NHPCO digital content will be restricted from future access to the event, and that person's registration will be canceled.

A Conference badge allows an Attendee entry to the overall Conference, but cannot guarantee admission to every session, lounge, or meeting area. Admission is subject to venue capacity and other requirements.

## Waiver of Liability

of the Conference or Conference-related activities, including but not limited to any education sessions presented in connection with the Conference, or for any indirect, incidental, consequential, special, punitive or exemplary damages. You further release and discharge such persons and entities from, and covenant not to sue such persons and entities with respect to, any and all risks, injuries, losses, damages and liabilities described herein.

You further agree that the maximum liability of NHPCO to you arising from your registration, participation, and attendance at the Conference shall be the return of your fees paid to NHPCO.

## Governing Law, Venue, Class Action Waiver, and Jury Waiver

You agree that any disputes related to your participation in and/or fees paid for the Conference shall be governed exclusively by the substantive laws of the Commonwealth of Virginia without giving effect to any choice-of-law rules that might result in the application of a different state's substantive law. You further agree that any action brought in these courts related in any way to the Conference, including without limitation your participation in the Conference and/or fees paid for the Conference, will be an individual claim, that you shall not bring claims against NHPCO in a representative capacity on behalf of any other individual, that you shall opt out of any class proceeding, and that you shall not assert class or collection action procedures. You further agree that both you and NHPCO waive any right to a trial by jury for any legal action related to the Conference, including without limitation your participation in and/or fees paid for the Conference.

This may also result in prohibition from registering or attending future conferences.
