Policy Updates

Guidance from CMS on Telehealth for Hospice Face-to-Face

NHPCO is confirming that the expansion of telehealth announced by President Trump and CMS Administrator Seema Verma yesterday <u>DOES NOT APPLY TO THE HOSPICE FACE-TO-FACE</u>

<u>REQUIREMENT at this time</u>. We are working closely with CMS to work through the issues and those discussions continue.

NHPCO Requests Meeting with CMS COVID-19 Team to Discuss Opportunities for Hospice 1135 Waiver

Today NHPCO requested a meeting with the CMS COVID-19 team to discuss requests for 1135 waivers for hospice providers. Included in that discussion will be waivers for face-to-face, allowing virtual visits, providing additional flexibility for continuous home care and allowing in-home respite care, to name a few. The meeting is expected before the end of the week.

NHPCO Sends Request to MACs to Pause TPE Audits

Today, NHPCO asked the three Medicare Administrative Contractors (MACs) for a pause in their TPE activity and asked that they bring our request to CMS for further discussion and approval. We heard back from all three MACs that the decision must be made by CMS and communicated to the MACs, but that it is under consideration. Stay tuned.
