# **Policy Updates**

#### **Questions About CARES Act Funding**

On Friday April 10, the Department of Health and Human Services began distribution of the \$30 billion in grant funding from CARES Act Provider Relief Fund for Medicare FFS providers in response to the coronavirus (COVID-19) pandemic (see the <a href="MHPCO press release">MHPCO press release</a>). The funding would have come into your account as HHS Payments. If no payment has been received as of today, providers may want to follow up with HHS to check the status of the payment. ## **CARES Act Funding Terms and Conditions**

HHS payment of this initial tranche of funds is conditioned on the healthcare provider's acceptance of the <u>Terms and Conditions</u> (PDF), which acceptance must occur within 30 days of receipt of payment. NHPCO has received many questions about the terms and conditions and will provide more detailed information on the considerations for hospice providers before accepting the money.

If a provider receives payment and does not wish to comply with these HHS Terms and Conditions, the provider must do the following: contact HHS within 30 days of receipt of payment and then remit the full payment to HHS as instructed.
