Policy Updates

Comments from Tuesday's CMS Call with Home Health and Hospice

Thomas Pryor, Hospice Lead for CMS Quality Safety & Oversight Group (QSOG) spoke and addressed last week's additional long-term care guidance from CMS and indicated that hospice staff were considered essential staff. Thomas also stated that when hospices are unable to gain physical access to patients in facilities to document to the best of their ability their efforts and collaboration, as there is "no complete fix to some of these things currently." CMS is continually working with long-term care to clarify that language for those long-term care facilities that are still not allowing for hospice staff visits. He also applauded the work of hospice bereavement support efforts.

OCR Issues Guidance on Covered Health Care Providers and Restrictions on Media Access to Protected Health Information about Individuals in Their Facilities

The OCR has issued additional guidance reminding covered health care providers that the HIPAA Privacy Rule does not permit them to give media and film crews access to facilities where patients' protected health information (PHI) will be accessible without the patients' prior authorization.
