CALL TO ACTION – Ask Congress to Include Support for Hospice and Palliative Care in COVID 4.0 Over 1,000 emails have already been sent to Congress urging for the inclusion of support for hospice and palliative in a fourth COVID Emergency Package, currently referred to as COVID 4.0. TAKE ACTION NOW by sending an email to your lawmaker underlining the need for bereavement support, funding, availability of community-based palliative care, and passage of the Rural Access to Hospice Act (H.R.2594/S.1190) and Palliative Care and Hospice Education and Training Act (S.2080). There are also scripts for phone calls and social media posts.
