## **Policy Updates**

### Small Business Administration (SBA) Issues Loan Forgiveness Guidance

Paycheck Protection Program (PPP) borrowers have been awaiting guidance from the SBA pertaining to loan forgiveness. On May 15, 2020, the SBA, in consultation with the Department of Treasury, released the PPP Loan Forgiveness Application, along with detailed instructions for the application. The SBA also issued a statement indicating that it "will also soon issue regulations and guidance to further assist borrowers as they complete their applications, and to provide lenders with guidance on their responsibilities."

### **House Passes HEROES Act**

On Friday, May 15<sup>th</sup> the House of Representatives passed a sweeping, \$3 trillion stimulus bill, the Health and Economic Recovery Omnibus Emergency Solutions Act or the HEROES Act <u>H.R. 6800</u>. The Republican Senate majority has no immediate plans to move this legislation through the legislative process. No legislation is expected to pass before the Memorial Day recess.

# Coronavirus (COVID-19) Update: FDA Authorizes First Standalone At-Home Sample Collection Kit That Can Be Used with Certain Authorized Tests

The FDA has authorized an <u>at-home sample collection kit</u> that can then be sent to specified laboratories for COVID-19 diagnostic testing.

The International Reagent Resource (IRR)external icon is distributing the <u>diagnostic panel and supplies</u> to registered state and local public health laboratories so they can perform SARS-CoV-2 testing.
