CARES Act Funding Deadline Approaching: Providers Must Act by June 3, 2020 to Receive Additional Relief Fund General Distribution Payment

Today, HHS made <u>an announcement</u> stating the following: "Eligible providers have until June 3, 2020, to accept the Terms and Conditions and submit their revenue information to support receiving an additional payment from the Provider Relief Fund \$50 billion General Distribution. All providers who automatically received an additional General Distribution payment prior to 5:00 pm, Friday, April 24th, must provide HHS with an accounting of their annual revenues by submitting tax forms or financial statements. These providers must also agree to the program Terms and Conditions if they wish to keep the funds."

Medicare 2% Sequestration Suspension and the Hospice Aggregate Cap

As previously reported, Section 3709 of the Coronavirus Aid, Relief, and Economic Security (CARES) Act suspended the 2% payment adjustment currently applied to all Medicare Fee-For-Service (FFS) claims due to sequestration. The suspension is effective for claims with dates of service from May 1 through December 31, 2020. Thank you to Ted Cuppett, the Health Group, for providing NHPCO with information about the interplay between the sequestration and the hospice aggregate cap.

Hospices that do not have a CAP liability will realize a two percent (2%) increase in Medicare payments for services rendered on or after May 1, 2020. Likewise, CAP hospices will realize a two percent (2%) increase as well. We have received many questions regarding how this increase in payments will impact the CAP liability for hospices with payments exceeding the aggregate payment limitation ("CAP"). The analysis includes examples reflecting the CAP liability and net cash flow impact assuming a hospice bills \$1,000,000/month for 2020.
