# SBA Releases Information on Paycheck Protection Program PPP Awardees

On July 6, 2020, the Small Business Administration (SBA) released <u>detailed information</u> regarding loans made under the Paycheck Protection Program (PPP). For loans of \$150,000 and above, the SBA disclosed, among other things, the name of the business, its address, its NAICS code, the lender, the number of jobs retained and the amount of the loan in the following ranges:

- \$150,000-\$350,000
- \$350,000-\$1 million
- \$1 million-\$2 million
- \$2 million-\$5 million
- \$5 million-\$10 million

For PPP loans of less than \$150,000, neither the name of the business, nor the address was listed, but the other information listed above was disclosed.

In releasing the information, the SBA announced that the format was aimed to ensure transparency for taxpayer funded programs and to protect small business' sensitive business information and privacy, including that of their employees. The SBA also made it clear that the release of this information does not mean that the SBA has determined that a borrower is eligible for a PPP loan or is entitled to loan forgiveness. Additionally, the SBA reiterated that all loans over \$2 million will automatically be reviewed.

# **HQRP COVID-19 PHE Tip Sheet is Available**

The HQRP COVID-19 PHE Tip Sheet is now available. This tip sheet provides practical guidance to address hospice quality data submissions starting on July 1, 2020 now that the temporary exemptions from the COVID-19 PHE ended. Hospices are expected to resume timely quality data collection and submission of CAHPS® Hospice Survey and HIS records. The CAHPS® Hospice Survey starts July 1 with July deaths. HIS also starts July 1 with all new HIS admission records and any HIS discharge records that occur on or after July 1, 2020. The CY 2020 data used for meeting the Hospice Quality Reporting Program requirements include July 1-December 31, 2020 since we exempted Q1 and Q2 of 2020 (January 1-June 30, 2020).
