COVID-19 Surges Back into Nursing Homes in Coronavirus Hot Spots

It is reported in *The Washington Post* that Federal data cited by two long-term care associations this week show that the number of new cases in nursing homes bottomed out at 5,468 during the week of June 21 and has climbed steadily upward to 8,628 for the week of July 19, the last week available. That is a 58 percent increase that roughly parallels the rise in U.S. cases overall during that time. Read on *The Washington Post* website.

Medical Device Shortages During the COVID-19 Public Health Emergency

The FDA has taken many actions to help ensure that patients and health care providers have timely and continued access to high-quality medical devices to respond effectively to the COVID-19 public health emergency. These actions include issuing Emergency Use Authorizations (EUAs) and guidance documents to provide recommendations and help expand the availability and capability for various diagnostic, therapeutic, and protective medical devices in high demand during the COVID-19 public health emergency. The FDA continues to monitor the healthcare landscape and supply chain for resulting shortages, or meaningful disruptions to U.S. supply, of certain medical devices. FDA Clears Saliva Test for Covid-19, Opening Door to Wider Testing (STAT News)

The Food and Drug Administration on Saturday authorized emergency use of a new and inexpensive saliva test for Covid-19 that could greatly expand testing capacity. The new test, which is called SalivaDirect and was developed by researchers at the Yale School of Public Health, allows saliva samples to be collected in any sterile container. It is a much less invasive process than the nasal swabs currently used to test for the virus that causes Covid-19, but one that has so far yielded highly sensitive and similar results. Mutation of The Coronavirus Discovered in Southeast Asia

Southeast Asia is facing a strain of the new coronavirus that the Philippines, which faces the region's largest outbreak, is studying to see whether the mutation makes it more infectious. The strain, earlier seen in other parts of the world and called D614G, was found in a Malaysian cluster of 45 cases that started from someone who returned from India and breached his 14-day home quarantine. The Philippines detected the strain among random Covid-19 samples in the largest city of its capital region. Learn more at the Bloomberg website.
