Policy

CMS Announces Resumption of Routine Inspections of All Provider and Suppliers

CMS announced it will resume routine inspections of all Medicare and Medicaid certified providers and suppliers to improve the safety and quality of life of patients and residents. CMS had previously suspended certain routine inspections as part of its response to the COVID-19 pandemic to prioritize infection control and immediate jeopardy situations and to give health care providers and suppliers time needed to respond to the spread of COVID-19. CMS has confirmed that this applies to all Medicare provider types, including hospice providers.

Resumption of Onsite Revisit, Non-Immediate Jeopardy Complaint, and Annual Recertification Surveys

In the <u>guidance released on August 17</u>, CMS directed the resumption of onsite revisit surveys, nonimmediate jeopardy complaint surveys and annual recertification surveys as soon as resources are available. In addition, <u>CMS is providing guidance on resolving enforcement cases</u> that were previously on hold because of survey prioritization changes. The agency will also temporarily expand the desk review policy, when state surveyors ensure that facilities return back into compliance with Federal requirements without an onsite survey, to include all noncompliance reviews except for immediate jeopardy citations that have not been removed.

Internal Pressure on Speaker Pelosi, McConnell Circulates Skinny HEALS Act

This Saturday, Speaker Nancy Pelosi will recall members of House from their home districts despite August Recess for a vote on legislation to secure and defend the Postal Service. Though Speaker Pelosi has publicly opposed passing a narrower version of COVID-19 relief in the past, she is now being pressured by some in her caucus to use this opportunity to also pass a slimmed down version of the HEROES Act. Senior leadership, though, have expressed concern that there is not consensus about which relief measures to include in this smaller bill. Meanwhile, as reported yesterday, Senate Majority Leader Mitch McConnell is circulating a similarly narrow version of the Republican COVID-19 relief bill, the HEALS Act. This version, the <u>Delivering</u> <u>Immediate Relief to America's Families, Schools, and Small Businesses Act</u>, would provide liability relief, \$300 in federal unemployment benefits, an extension and modification of the PPP, and funding for the Postal Service. Though some senate Republicans in swing districts would like to see a bill move, it is unlikely that this bill would come up for a vote before September.

CISA tracking phishing activity

The Cybersecurity and Infrastructure Security Agency (CISA) is tracking an unknown malicious cyber actor spoofing the Small Business Administration (SBA) COVID-19 loan relief webpage through phishing emails. These emails include a malicious link to the spoofed SBA website being used for malicious redirects and credential stealing.
