## HHS Final Rule to Strengthen Nondiscrimination Protections in Health Programs and Activities

On April 26, the Department of Health and Human Services (HHS) Office of Civil Rights and the Centers for Medicare & Medicaid Services (CMS) released a final rule, <u>Nondiscrimination in</u> <u>Health Programs and Activities</u>. In a <u>statement</u>, CMS Administrator Chiquita Brooks-LaSure said, "Today's rule is another important step toward our goal of health equity – toward the attainment of the highest level of health for all people, where everyone has a fair and just opportunity to attain their optimal health." HHS has provided a <u>fact sheet</u> and <u>FAQs</u> accompanying the final rule. NHPCO previously <u>commented</u> on the proposed rule, expressing support for many of the finalized provisions. The final rule is effective July 5, 2024, 60 days after publication in the Federal Register.

## **REGULATORY & COMPLIANCE**

## CMS To Delay Implementation of Physician Enrollment Requirements

On April 22, NHPCO and NAHC met with CMS to address implementation challenges associated with the requirement that physicians must be enrolled or validly opted out of Medicare to certify a patient's terminal illness under the Medicare hospice benefit. Following our meeting, CMS issued a new <u>Questions and Answers (Q&A) Document</u>, which provides additional guidance regarding hospice certifying physician enrollment requirements. Last week, CMS alerted us that the May 1 live date for the hospice certifying physician enrollment requirement will be **delayed to Monday, June 3**. CMS provided updates on the future of the Hospice Outcomes and Patient Evaluation (HOPE) in the FY2025 Hospice Wage Index and Payment Rate Update Quality Reporting Proposed Rule. NHPCO will be hosting a series of roundtables to discuss the Proposed Rule and to solicit member feedback, including a session on May 16 at 12 p.m. ET, focused on HOPE, payment implications, and quality measures. ## Fast Fact #482: Alpha( $\alpha$ )-2 Receptor Agonists in Palliative Care

Alpha-2 adrenergic receptor agonists ( $\alpha$ 2–AR) are a class of drugs used for a variety of indications, including hypertension, pain, and sedation; however, in the field of palliative medicine, most clinicians use these medications to manage opioid withdrawal.  $\alpha$ 2-AR medications (such as Clonidine, Dexmedetomidine, and Guanfacine) have a wide range of use for seriously-ill patients and are available in several formulations for administration (oral, transdermal, intrathecal). Clinicians interested in learning more about how  $\alpha$ 2-AR agonists can help with symptoms experienced by seriously-ill patients should review Fast Fact #482 or check out the full library of PCNOW's helpful facts.

## RFI on Potential Hospice Quality Reporting Program Social Determinants of Health

On April 4, CMS published the <u>FY 2025 Hospice Wage Index and Payment Rate Update</u>. With the proposed rule, CMS asks for feedback on different topics as they develop the final rule for FY 2025 and future payment policies. These requests are an opportunity to provide CMS with "on-the-ground" experiences in providing care to Medicare beneficiaries. NHPCO requests information from providers regarding the RFI on Potential Hospice Quality Reporting Program Social Determinants of Health Items included in the proposed rule. <u>Please complete the survey</u> by May 10. #### Report: The Nature of the Rural-Urban Mortality Gap

The <u>USDA Economic Research Service</u> published a report exploring how working-age (ages 25– 54) natural-cause mortality varies by individual characteristics and regions of the country. After examining the population by sex, race and ethnicity, region, and state, the report lists an increase in the rural, prime working-age natural-cause mortality rates and a decrease in the corresponding urban rates are contributing to the growing mortality gap.

#### Promoting Indigenous Research Leadership

The <u>Promoting Indigenous Research Leadership</u> three-day workshop, held November 18-20 by the Center for American Indian and Rural Health Equity, is designed to promote the public health research careers of Indigenous and other early-career faculty working with Indigenous communities across the country.
