I recently had the privilege of <u>testifying before the House Ways and Means Committee</u> to discuss the value of hospice and palliative care in caring for aging Americans. During the hearing, I shared my Great Aunt Ruby's story. Ruby is a former Pentagon staffer living on her own with end-stage Chronic Obstructive Pulmonary Disease (COPD) – a condition for which there is no cure. Managing her illness requires a significant amount of support, care, time and energy. It is simply too much for Ruby to handle on her own, and when complications arise, she often ends up calling 911 and being taken by ambulance to the emergency room.

Although COPD is a terminal illness, Ruby does not consider herself to be terminally ill and therefore does not believe that she is ready for hospice. With hospice, she would have access to person-centered, integrated care to better manage her disease and prevent costly hospitalizations. In addition to pain management, she would receive social, emotional and spiritual support, which would help my great aunt and our family come to terms with her illness. Without hospice, she is depressed and declining and has access to none of these unique benefits.

Unfortunately, like Aunt Ruby, too many aging and seriously ill Americans face barriers that limit access and choice when it comes to their health care. Improving care will require many reforms, and fortunately, there are solutions on the table that would be a step in the direction of strengthening hospice and palliative care in America.

Act (S. 1190/H.R. 2594), which will allow providers working in Rural Health Centers (RHC) and Federal Qualified Health Centers (FQHC) to receive payment for hospice services while acting as attending physicians for their patients. Under the legislation, RHCs and FQHCs would be able to bill and be paid for hospice attending physician services the same way they are currently paid for providing other services. Passing this bill will ensure individuals and families living in rural and underserved areas can select hospice without jeopardizing their relationship with their trusted physician.

Second, the Senate should pass the Palliative Care and Hospice Education and Training Act (PCHETA). This legislation would improve and expand professional training to meet the growing demand for hospice and palliative care. Already passed in the House with strong, bipartisan support, it is time for the Senate to act quickly to pass this bill and send it to President Trump's desk for his signature.

Without the support and resources this legislation provides, recent projections suggest that by 2030, there will only be one palliative care physician for every 26,000 seriously ill patients. Based on the influx of seniors entering the Medicare program daily, our senior care system cannot withstand such a shortfall of health care professionals. Therefore, Congress should finish the job and pass PCHETA this year.

At the same time, Congress should work with stakeholders to ensure better hospice care and smart oversight of that care. As I announced at last week's hearing, we have been working with leaders in both Congress and the administration to develop policies that would implement safeguards, improve education and enhance information available to consumers, all of which would support the hospice provider community in offering patients and

families the highest quality hospice care possible. To that end, we support the policies that enhance smart oversight in the Hospice Care Improvement Act of 2019 (S. 2807). This bipartisan legislation implements new safeguards and strengthens existing ones in order to protect patients facing serious illness at the end of life.

At the hearing, many committee members shared their own family members' stories of struggling with serious illness and benefiting greatly from hospice care. The Medicare Hospice Benefit has so much to offer to patients and families, but more must be done to reach and support them. It is important for the government and other key stakeholders to work together to put policies in place that ensure adequate access to highly trained health professionals, remove unnecessary barriers to care, and advance reforms to improve program integrity.

In addition to the evolutionary but meaningful reforms we have mentioned, it will also be necessary to fundamentally question some of the outdated requirements that restrict access to much-needed care. Why?

Because my Great Aunt Ruby's story is not unique. Why do people have to be dying in order to get person-centered, interdisciplinary care? Why don't we have a community-based palliative care benefit in Medicare? These are all questions that we will seek to work on and answer with our partners.

I applaud the Ways and Means
Committee for shining a light on
the issues impacting aging
Americans and other leaders in
Congress who have recognized
the critical role hospice care plays
in our health care system, have
championed hospice issues and
are working with the provider
community to advance these
important legislative solutions. By
working with stakeholders to
strengthen the Medicare Hospice
Benefit, Congress can do what is
best for all Americans.

Rob Portman (R-OH) and Ben
Cardin (D-MD) introduced S.
2807, a bipartisan bill entitled the
Hospice Care Improvement Act of
2019, specifically written to
address the concerns identified
by the HHS Office of Inspector
General about hospice survey
deficiencies and patient harm.

The bill also prioritizes consumer education by supporting access to relevant and clear information about hospice providers, intended to lead to greater transparency and more informed care decisions. State and local survey agencies and accrediting agencies will be required to report survey information, including targeted deficiencies to the Center for

Medicare and Medicaid Services' Hospice Compare website.

NHPCO supports many of the policies in the bill as it closely tracks NHPCO's recommended Hospice Program Integrity Initiatives published earlier this year. Appreciation goes out to members of the Legislative, Regulatory, and Quality & Standards Committees who all worked diligently on vetting and approving many of the program integrity measures that were included in this legislation.

This article offers some background and analysis for providers.

## OIG Reports and Program Integrity

The HHS Office of the Inspector General (OIG) issued two reports in July 2019 that outlined deficiencies with CMS monitoring of hospice and examples of poor care. For more details on the July reports, see the NHPCO Regulatory Alert (07/09/19). The reports - and subsequent reports from the OIG - have attracted a great deal of negative attention from policy makers, were featured on NPR and NBC Nightly News and caused some members of Congress to say that "we have to do something about hospice." The "do something" could have meant public hearings on hospice, a Congressional investigation or worse, definitely not the publicity that the hospice community would want.

NHPCO staff immediately began discussions with the relevant Congressional committee staff – on the House side, the House Ways and Means Committee and on the Senate side, the Senate Finance Committee. The "do something" discussion evolved into creating a hospice program integrity bill that would address some of the issues identified for CMS by the OIG.

Discussions with both the OIG and CMS identified key areas where legislative action could be helpful in addressing hospice program integrity issues.

## Regulatory, Legislative Affairs and Quality & Standards Committees

Shortly after the OIG reports were published, NHPCO staff engaged the Regulatory, Legislative Affairs, and Quality & Standards Committees to discuss hospice program integrity issues identified by the OIG. Staff shared concerns voiced by policymakers, House and Senate committee staff, and the OIG and CMS with the three NHPCO committees to examine and to identify a series of program integrity initiatives that would address the concerns noted in the OIG reports.

Each committee voted on each of the program integrity initiatives and only those that were approved by all three committees were included in the final NHPCO Program Integrity Initiative.


NHPCO staff shared the Program Integrity Initiative document in discussions with legislative champions and the Administration to craft draft legislation that would balance the need for smart, targeted oversight and education without imposing excessive regulatory burden.

#### **Alternative Sanctions**

Discussions with both OIG and Congress centered around their desire to identify alternative sanctions for hospice, named as an issue by the OIG. Alternative sanctions for hospice are not currently available and must be authorized in statute for CMS to take any action for a hospice provider's deficiencies, short of decertification.

The alternative sanctions listed in the bill mirror those for home health, without the additional civil monetary penalties sanction. The most serious of the alternative sanctions, partial or full suspension of payments for all new admissions, is a very serious alternative sanction and could be used when the survey deficiencies identified have implications for significant patient harm. There is a provision in the bill, however, that gives the Secretary discretion to add other alternative sanctions.

The addition of alternative sanctions gives CMS and surveyors options to use in correcting survey deficiencies short of decertification. More detail on the specific alternative



sanctions can be found on page 3, Section 3 of the bill (S. 2807).

#### **Provisions of the Bill**

The Hospice Care Improvement
Act of 2019 includes provisions
that aim to increase reported
hospice data, improve the hospice
survey process, and increase
compliance of quality standards
for hospice care. Details about
the bill follow.

#### **NHPCO Concerns**

NHPCO remains concerned about the title of the bill and would like to see a reference to smart and effective oversight of hospice programs.

Another concern is that this legislation does not incorporate the provisions of the Rural Access to Hospice Act (H.R.2594/S.1190) which is an important statutory fix for the barrier Medicare beneficiaries face when they are served by a Rural Health Clinic (RHC) or Federally Qualified Health Center (FQHC). NHPCO will continue to advocate for the inclusion of the Rural Access to Hospice Act in any program integrity packages that may be under consideration.

NHPCO looks forward to working with our legislative champions in the Senate to shepherd this bill through the legislative process and to further refine the legislation to include enhanced access to hospice care.

Additionally, we will continue to engage with our House champions on a companion bill that is expected to be introduced at any time (and may have already been introduced since this issue of *NewsLine* went to press).

To the many members who reached out, engaged, participated in focus groups, conferred in committees, and contacted their Members of Congress to make this bill a reality, NHPCO extends its appreciation. We look forward to continuing grassroots engagement and appreciate your ongoing commitment to high-quality, person-centered care for all Americans.

- Created monthly business webinar series, free for members.
- Buyers' Guide online and hardcopy mailed to members.
- Kicked off The Hospice Music Project following LAC in April.

## Philanthropy: National Hospice Foundation

- Through the Lighthouse of Hope fund, NHF awarded more than 40 grants to hospice patients to have a wishfulfilling experiences.
- Through its disaster relief fund, NHF awarded \$10,000 to assist programs in Africa that were impacted by Cyclone Idai.

## THE GIFT OF LEGACY

#### My Legacy, My Hospice: Lou's Story

At the 2019 Interdisciplinary
Conference in Orlando, Florida,
NHPCO premiered a new video
for the My Hospice Campaign
– My Legacy, My Hospice: Lou's
Story. The video features Lou
Alvarez, the 9/11 first responder
who captured the attention of
people across the world when he
testified on Capitol Hill in June of
2019 to advocate for passage of
the 9/11 Victim Compensation
Fund. He was admitted to
hospice care days after his
testimony.

In the video, viewers meet Lou Alvarez, an NYPD detective who responded to the 9/11 World Trade Center attacks. Lou spent three months at Ground Zero in the recovery effort. Then, in 2016, he was diagnosed with stage 4 cancer, a direct result of his time spent in the toxic fumes. Immediately following his diagnosis, he became an advocate for fellow 9/11 first responders, encouraging them to get checked by the doctor yearly and to sign up for benefits through the World Trade Center Health Program.

In June of 2019, despite being severely ill, Lou made a trip to Washington, D.C., to testify before Congress to encourage passage of the Victim Compensation Fund. His testimony on Capitol Hill went viral and his words and fighting spirit inspired many around the world. Days after his testimony, Lou was told by doctors that continuing treatment would be futile, and he was admitted to

Catholic Health Services of Long Island's Good Shepherd Hospice.

Through expert care and support, hospice helped Lou continue his fight to advocate for the 9/11 Victim Compensation Fund and even arranged television interviews from his hospice room. The team at Good Shepherd Hospice ensured that Lou was able to maintain dignity, comfort, and support while being surrounded by his loved ones and the many visitors he received in his final weeks.

"We really created the space to allow him to be him," said Good Shepherd Hospice Nurse Josephine O'Connor, RN. "Baseball cap, kids at the bedside, mom bringing in food."

Hospices in the New York tristate area are seeing more 9/11 first responders being admitted to their service because of time spent at Ground Zero; most patients have a cancer diagnosis. These men and women are a unique demographic, having witnessed the horrific events of the day and working in the dangerous conditions in the months following. Many of the patients are young and have sought aggressive treatment to cure their illness.

Phil Alvarez, Lou's brother, now works for a firm that helps identify 9/11 first responders and survivors who have not signed up for benefits under the World Trade Center Health Program or

the 9/11 Victim Compensation Fund. Further, not many people know that hospice is covered under the program.

"Folks from all over the United States descended on Ground Zero coming to the aid of a city and a country knocked to its knees," says Alvarez. "Military, law enforcement, fire departments and volunteer-based organizations like the American Red Cross, volunteered to help. Today many of these folks, who have returned to their home states, have gotten sick from many of the illnesses associated with breathing the toxic air of Ground Zero."

"Hospice programs around the country need to be aware of this

and be trained to recognize that the patient may be a 9/11 responder or victim and are eligible for health and compensation benefits," Alvarez continued.

NHPCO shares Lou's Story with the goal to educate more people about the 9/11 Victim
Compensation Fund and the increasing number of 9/11 first responders entering hospice care. Lou's Story is part of the My Hospice campaign – an initiative to educate policymakers and their constituents about the value of the Medicare hospice benefit.

"We honor Lou Alvarez. He was a veteran and first responder, and he immediately jumped to action on 9/11," said NHPCO President and CEO Edo Banach. "We are proud to share his hospice story and continue his message to ensure that all 9/11 first responders get the care that they deserve."

National Hospice
Foundation Gives
Pediatric Patients and
Families Special Orlando
Experience

As the NHPCO team prepared for the trip to Orlando, Florida for the 2019 Interdisciplinary



Conference, staff discussed bringing their children along to Florida and taking them to the theme parks. Realizing that many of the pediatric patients cared for by hospice and palliative care providers may never have the chance to make those childhood memories, the team decided to offer grants to those families so they can also have special family experiences.

In conjunction with IDC, fundraising affiliate National Hospice Foundation partnered with Give Kids the World Village to provide a special Orlando "Magical" experience to three pediatric hospice or palliative care patients and their families.



This trip included theme park tickets, all meals and lodging for the patient and their parents and siblings, and travel reimbursement from NHF's Lighthouse of Hope Fund.

One of the kids who received a grant to go to Orlando and Give Kids the World Village was Alivia Robinson, a 14-year-old girl under the care of Arkansas Hospice. Her family had limited resources and the only trips they had taken were for medical needs. Alivia had never been to Orlando or even had a family vacation. Her hospice team said she wanted the opportunity to just be a kid and have some fun, and for the family to connect with each other and be a more "normal" family.

Alivia and her family had a blast visiting the theme parks in Florida, her mom Telisa Whitely said. Alivia and her sisters rode nearly every ride in every park, and Alivia got to have her picture taken with Mickey Mouse.

"It was a once in a lifetime trip," Telisa said. "I was very thankful."

One of the other grant recipients was Boston Pimpare, an eight-yearold boy receiving care from Cranberry Hospice in Massachusetts. His hospice team noted that while Boston is restricted to a wheelchair, is blind and cannot move or speak, he responds beautifully to music, movement, and laughter. His two sisters actively assist in his care, and the family of five thrives when they can all participate in something together. The trip to Florida provided that exact opportunity for Boston and his family.

Boston's dad, Jay Pimpare, said all three kids got to fully experience everything together, and no one was left out. Boston especially loved his ride on a small roller coaster, as he could feel the movement and the wind in his face.

Jay also spoke highly of Give Kids the World Village. Give Kids the World is unique because it provides housing, meals, theme park tickets, and on-site entertainment to families with a seriously ill child. Each family has their own villa, everything is

handicapped accessible, and Give Kids the World offers activities like face painting and horseback riding for the kids and their siblings.

"All the families were going through the same thing," Jay said. "You just get it. You don't have to say anything."

NHF and NHPCO were proud to support this special opportunity for these families and the organizations look forward to ongoing efforts that NHF's Lighthouse of Hope will make available.

"Maximizing quality of life for patients and family caregivers is at the heart of the hospice philosophy of care," said Edo Banach, President and CEO of NHPCO and NHF. 
### The Hospice Music Project Into the Light Debuts at IDC in Orlando

#### How it All Started

During the 2018 Interdisciplinary Conference in New Orleans, Grammy Award winner Tricia Walker and hospice physician and musician John Mulder led a songwriting workshop that followed John's keynote presentation. With the help of over 60 participants in the workshop, they captured the passion, poignancy, and purpose of the work that hospice and palliative care professionals do in providing care and supporting families. From that workshop, the song *Joy in a Teardrop* was created and performed live on stage by John and Tricia at the closing keynote session.

Following the IDC in New Orleans, *Joy in a Teardrop* was professionally recorded and formally released at the NHPCO Leadership and Advocacy Conference in April 2019. The song was synchronized with a series of photographs that had been submitted to NHPCO by members over the past several years – the impact was powerful.

Many have been touched by the images and the music, demonstrating the power of music and art to instill peace, foster healing, and reveal joy in situations that could otherwise be discouraging and even devastating. Hospice staff have experienced renewed commitment to and vigor in the work that they do, as this song reminds them of the deep value and positive outcomes in the care that they provide for their patients and families.

This November, NHPCO was proud to release additional chapters to the *Playbook*:



The Palliative Care Needs Survey Report is available for download on the NHPCO website.) Survey findings indicate that 88 percent of survey participants are involved in community-based palliative care; with 53 percent already providing palliative care services and 35 percent in the process of developing a palliative care program.

Interested individuals must submit a Letter of Intent by February 21, 2020. After review, a select group of applicants will be invited to submit full grant applications by June 19, 2020.
